ONTARIO SOCCER ASSOCIATION PARTICIPATION AGREEMENT FOR THOSE UNDER 18 YEARS OF AGE

IN CONSIDERATION of allowing my minor child/ward to participate in the programs, activities and events of The Ontario Soccer Association, I ASSURE TO YOU THAT:

I am the parent/guardian of the participant named in the registration form, have full legal

- responsibility for decisions regarding the above named participant
- I believe that my child/ward is physically, emotionally, and mentally able to participate in the programs, activities, and events of The Ontario Soccer Association
- I hereby acknowledge that I am aware of the risks and hazards associated with or related to soccer. The risks and hazards include, but are not limited to, injuries from:
- Executing strenuous and demanding physical techniques in soccer Dryland training including weights, running, and massage Grass, turf, and other surfaces including bacterial infections and rashes

- Falls to the ground due to uneven or irregular terrain or surfaces Collisions with walls and soccer equipment
- Failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment
- Extreme weather conditions which may result in heatstroke, sunstroke, or
- hypothermia Contact, colliding or being struck by other participants, spectators, equipment, or 0 vehicles
- Vigorous physical exertion and strenuous cardiovascular workouts
- Exerting and stretching various muscle groups
 Travel to and from competitive and/or non-competitive events and activities which are an integral part of the organization's activities

- **FURTHERMORE**, I am aware that my child/ward may:

 Sustain injuries in soccer that can be severe, cause spinal cord injuries and even be fatal
- Experience anxiety while challenging himself/herself during the activities, events, and
- Come into close contact with other participants, including the possibility of accidental and unexpected contact
- Risk of injury is reduced if he/she follows all rules established for participation
- Risk of injury increases as he/she becomes fatigued

I UNDERSTAND AND AGREE, on behalf of myself, my heirs, assigns, personal representatives and next of kin that my signing/submitting of this document constitute

- I am registering my child/ward willingly and my child/ward is participating voluntarily in these activities, events, and programs
- I agree that there are risks in soccer as described above and my child/ward will be exposed to these risks and hazards
- I agree to accept all these risks and hazards and be responsible for any injury or other loss which my child/ward might receive while participating in these events, activities, and programs
- I release the Organizers of responsibility for any claims, demands, actions, and costs which might arise out of my child/ward's participation

 I understand "Organizers" to mean: The Ontario Soccer Association, District Association,
- Leagues, Clubs and their directors, officers, members, employees, volunteers, officials, participants, clubs, agents, sponsors, owners/operators of facilities, and representatives

Accident Insurance: Executing this agreement will not preclude you from accident insurance coverage, subject to the terms and conditions of The Ontario Soccer Association's insurance

ACCEPTANCE OF TERMS AND CONDITIONS

In consideration of the acceptance of my child/ward's membership with The Ontario Soccer Association, District Association, and Club, I, the parent guardian (for the participant under 18 years of age), agree as follows:

- I understand that my child/ward cannot play in any sanctioned soccer game until after the registration form has been validated and the registration date has been entered in the Club's computerized registration system
- I have reviewed the participation agreement above and my signature or submission of this registration form indicates my agreement with such participation agreement
- I am aware of The Ontario Soccer Association, EODSA, OSU, and League bylaws, policies, rules and regulations, and agree to abide by them and to be bound by them
- I accept sole responsibility for my child/ward's personal possessions and athletic equipment
- I accept all liability for any damage to the playing equipment caused by my child/ward's careless, negligent and/or improper handling

I ACKNOWLEDGE MAKING THIS AGREEMENT By signing and dating or submitting a registration form, you agree that you are the parent or legal guardian of the player being registered and to be bound by this Legal Agreement even if you have not read the agreement.

* VOLUNTEERS - Any dispute of what constitutes a volunteer for Club Membership status is subject to the final decision of the Club's Board of Directors.

REGISTRATION AND REFUND POLICY - APPLIES TO ALL **PLAYERS**

Payment of Registration Fees

- Full payment for registration must accompany the registration form
- Payment must be cash, cheque, debit, or credit card (where available) Payment is made out to Ottawa South United or OSU
- Every player is responsible for their own registration and payment of fees
- Ottawa South United S.A. shall NOT be responsible for any monies paid to a team, team coach, or team official and shall not entertain requests for any such refunds

Please take the time to familiarize yourself with our refund policies.

A) All refunds are:

- Subject to a \$30.00 administration fee
- The competitive tryout fee is non-refundable
- Must be made in writing, by email, or online by June 30th, and clearly indicate the reason
- Do not ask a coach or other volunteer to pass on verbal requests, as they WILL NOT be accepted
- Refund requests made over the phone or through voice mail WILL NOT be accepted
 Refunds will only be issued once uniforms and equipment are returned to the club
 Refund cheques will be issued on the 15th of each month, beginning on June 15th
 B) Full refunds (less the \$30 administration fee):

Will be processed for requests prior to May 15th

- Where a player trying out for a competitive team is not selected and OSU is unable to provide a suitable alternative within the recreational program
- Where a player trying out for a competitive team is not selected for a specific team and player decides to leave OSU immediately after tryouts
- Where a Developmental or Recreational player identifies a specific geographic site and OSU cannot accommodate the request

C) Partial refunds (50%, less the \$30 administration fee):

- Will be processed for requests between May 15th and June 30th
- Where a player suffers a season ending injury, attested to by the attending physician prior to July 1st, the refund will be prorated by the number of games up to the time of injury, less any fees paid to leagues or governing bodies

 Apply to recreational players only, under the conditions of item B), above

D) Refunds WILL NOT be processed under the following conditions: Written requests received after June 30th

- Competitive players withdrawing after they have been offered and accepted a team assignment, NO EXCEPTIONS
- Where a player transfers to another club after OSU has registered them with the governing soccer organizations, NO EXCEPTIONS
- Where a player has been disciplined by one of the governing soccer organizations, the club or has outstanding debts to the club

E) All other refund requests will be assessed on merit

Outstanding Fines: A player will NOT be registered for their respective league if outstanding fines or fees are not addressed

Competitive Team Fees: A player will NOT be registered with the ERSL (Regional) and OYSL until the additional fee assessed to Regional and OYSL players is paid

CONSENT FOR PERSONAL USE OF INFORMATION

I authorize the Canadian Soccer Association, Ontario Soccer Association (OSA), Eastern Ontario District Soccer Association (EODSA), and OSU to collect and use personal information about my child/ward for the purpose of delivering a quality soccer program and receiving relevant communications from any of the organizations listed above. OTTAWA SOUTH UNITED SOCCER ASSOCIATION PRIVACY POLICY

The Ottawa South United Soccer Association (OSU or the Club) is committed to protecting your privacy. You can visit most pages on our Web site without providing us any information about yourself. On some of our pages we do require personal information from you. This privacy statement explains our policy related to the collection, storage and distribution of this

What do we collect?

On pages where we do require personal information from you we will clearly state that we are collecting this information and will provide a link back to this privacy statement. Most often this information is required for registration purposes, and as such includes demographic information used to contact you by regular mail, email or telephone. It also includes information required to deliver a quality soccer program. This may include, but is not limited to, program selection, age, gender, position, ability, equipment sizing, location preferences, and friend requests. In addition, emergency medical information is required should an accident occur and medical assistance need to be provided. Any online financial transactions are processed by a secure third-party, and no information other than the amount paid and the date and type of payment are delivered to the Club.

How is your information used?Your personal information is used for the following purposes:

- to ensure our site is relevant to your needs
- to deliver a quality soccer program, including building team rosters for coaches and other team volunteers to contact their players

- to alert you to important dates, events and meetings to register with the Club for a specific program we occasionally hire other companies to provide limited services on our behalf including mailing newsletters. We will only provide those companies with the information they need to deliver the service, and they are prohibited from using that information for any other

OSU may disclose your personal information if required to do so by law or in the good-faith

- belief that such action is necessary to:
 conform to the edicts of the law or comply with legal process served on OSU or the site;
- protect and defend the rights or property of OSU and its website, or act in urgent circumstances to protect the personal safety of the OSU employees, users of OSU programs or services, or members of the public.

Control of your information

When you register, or otherwise give us personal information, OSU will not share that information with third parties without your permission, other than for the limited exceptions already listed. It will only be used for the purposes stated above.

OSU is a volunteer based association. All volunteers and those engaged as contractors by OSU are subject to a reference screening process prior to any involvement with the club and access to your information. At all times, OSU will ensure that access to only the portion of the information required by the role, to complete the activities associated with that role will be permitted. These individuals include: Registrar, Schedulers, Coordinators, Coaches, Assistant Coaches and Managers, Trainers, Camp Counselors, Club's Board of Directors, Club Administrator, Club General Manager
